Use rich pattern-based classification policies to assign customized retention periods. You can also apply a default policy to all archived information, specific individuals, or individual items via rich pattern-based classification policies, to assign custom retention periods that align with your business requirements. Automated daily storage expiry ensures applicable content is removed consistently and defensibly per policy. Your retention policies also cover archived content from former employees.

## Streamlined Compliance and Defensible eDiscovery

Veritas provides a purpose-built tool to capture email, attachments, and all message metadata. It time stamps and serializes archived content with a unique signature to ensure authenticity. Native journaling ensures full content and recipient capture, so you always know who received what and when, regardless of user behavior. If required, you can proactively archive and store content on 17a-4-compliant immutable storage, or reactively collect it from the source and produce it as needed.

- Ensure that retention and storage practices comply with applicable laws and surveillance.
- Make sure eDiscovery practices are defensible.
- Provide rapid search, legal hold, case management, and eDiscovery workflows to reduce costs and improve the productivity of IT and litigation support staff.
- Transition from CAPEX to OPEX accounting with subscription licensing to stabilize archiving costs, regardless of data growth.

Take your cloud archive further with eDiscovery. Apply a legal hold across keyword searches and users, or target specific legal custodians. You don't have to put mass restrictions on large groups or user domains, or establish challenging retention management rules to address regulatory compliance. For example, suppose an end-user deletes or modifies a message in their inbox or personal folder. In that case, the original remains in the journaled Veritas cloud archive, regardless of whether a legal hold exists.

Cloud archiving search and eDiscovery capabilities provide workflows to scan massive amounts of data quickly, iteratively filter out non-relevant results, and then collect and organize results by case or legal matter. Uploading data directly through Targeted Collections using eDiscovery allows you to manually ingest data into a self-collected or produced case.

Search and collate millions of records in seconds. And when collection is complete, make the results available online to outside legal partners. During review, role-based access controls help ensure proper data handling to automatically maintain a secure evidentiary chain of custody. When you need to produce content for external consumption, you can quickly and efficiently export it — a task you can't perform with a cloud platform.

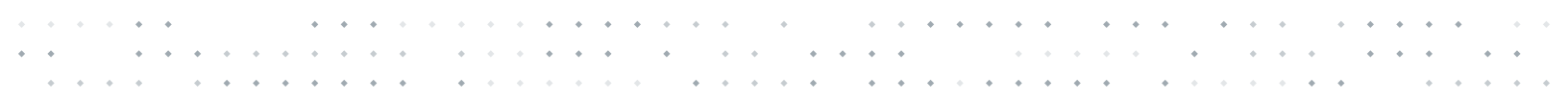
